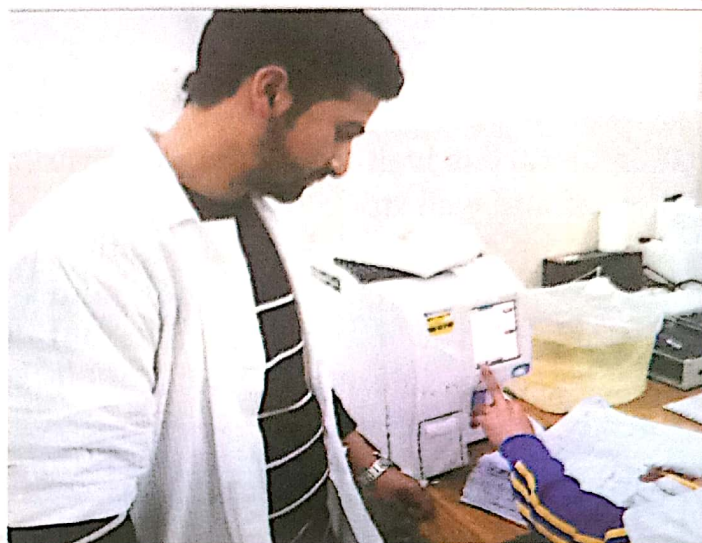

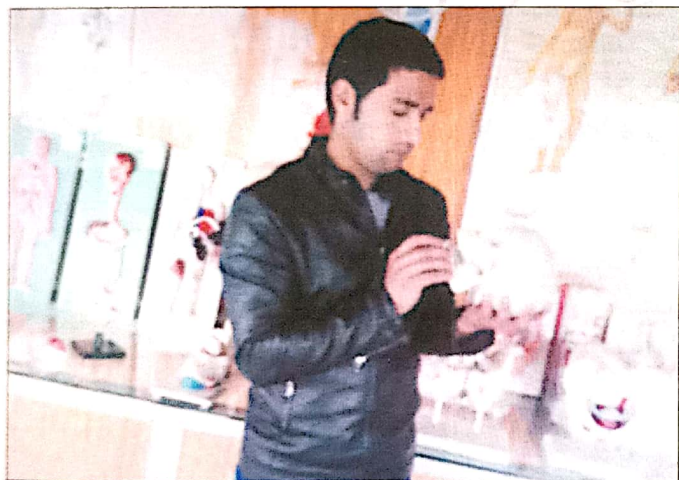
#### IV) Anatomy Lab:-

### VII) Library:-

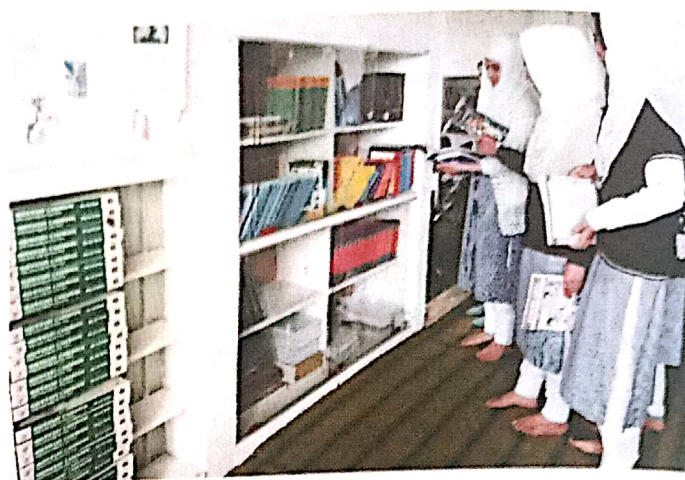
